### 3. General data processing

Personal data is processed primarily for the following purposes:

- To fulfill our contractual obligations.

If personal data is processed for a purpose other than the one for which the personal data was collected, we inform the data subject of other purposes.

We do not carry out automated decision-making, including profiling.

### 4. Your rights as a data subject

The data subject has the right to

- information about the data stored according to Article 15 GDPR,
- the rectification of inaccurate personal data pursuant to Article 16 GDPR,
- the deletion of personal data pursuant to Article 17 GDPR,
- the restriction of the processing of personal data pursuant to Article 18 GDPR,
- object to the processing of personal data pursuant to Article 21 GDPR,
- data portability pursuant to Article 20 GDPR.

If the processing takes place on the basis of a declaration of consent, the data subject may revoke their consent at any time without this affecting the lawfulness of the processing that

took place on the basis of the consent up to the point of revocation. The data subject has the right to complain to the supervisory authority – the responsible body in Austria is the Data Protection Authority. The address is:
